In exchange for participation in all activities of Equestrian and Non-Equestrian events organized by the Mountain Rodeo Association ("Squaw Valley MRA or MRA"), of 30750 E Kings Canyon Road, Squaw Valley, CA 93675 and/or use of the Rodeo Grounds, facilities, and services of MRA, I agree for myself and (if applicable) the members of my family, to the following:

1. I agree to observe and obey all posted rules and warnings, and further agree to follow any oral instructions or directions given by MRA Board Members, or representatives, or agents thereof. \_\_\_\_\_
2. I recognize that there are certain inherent risks associated in dealing with, or being in the near proximity of, any and all livestock, that the animals may, at any time, behave in an unpredictable manner that may cause injury to me or others. I assume full responsibility for personal injury to myself and (if applicable) to my family, including minor children. I further release and discharge MRA for injury, loss, or damage arising out of my, or my family's use of, or presence upon the facilities of the MRA Rodeo Grounds, whether caused by the fault of myself, my family, MRA Members, show management, arena renters, volunteers, board members, or property owners or other third parties. \_\_\_\_\_
3. I agree to indemnify and defend MRA against all claims, causes of action, damages, judgments, costs, or expenses, including attorney fees and other litigation costs, which may in any way arise from my or my family's use of or presence upon the MRA Rodeo Grounds. \_\_\_\_\_
